INVERNESS POOL PARTY RULES

- 1) Parties will be defined as a group of **6 or more GUESTS and no more than 45 GUESTS**. Inverness pool management retains sole discretion to determine whether a group of GUESTS constitutes a party.
- 2) Pool management must be given at least one week notice for a pool party if the number of GUESTS (children under 15 years old) exceeds 20. See section 12 below.
- 3) An adult registered pool member must sign up using the party reservation system and pay for the pool party using the membership system. Pool reservations will be on a first requested, first granted basis. The ability to reserve any specific date will be subject to its availability. No reservation will be complete without payment. The member who signed up for the pool party will be responsible for all costs associated with the party, including fines.
- 4) Party reservation will include the picnic tables and one of the grills. The maximum time of reservation of the picnic tables and grill is three hours.
- 5) The HOA member who is making the reservation must be registered with the pool and current with his/her homeowner's assessments.
- 6) Only registered adult members will be able to sign up for a pool party. When signing up the member acknowledges that he/she has read and understands the rules and regulations governing pool guests and guests conduct on Inverness property.
- 7) The lifeguards will post a sign that states which day and time the picnic tables and grill have been reserved.
- 8) The host/hostess of the party must provide set up and clean up. Within two hours and thirty minutes after the registered start time of the party the picnic tables and grills must be clean and returned to their pre-party condition. A fine of \$50 will be charged if the party area isn't cleaned.
- 9) **NO GLITTER OR CONFETTI ARE ALLOWED.** A fine of \$50 will be charged if glitter and/or confetti is used.
- 10) Parties with children (under 15 years old) must provide adult supervision as follows:
 - a. Children between the age of 13 and 15 – at least 1 adult per 10 children
 - b. Children between the age of 8 and 12 – 1 adult per 8 children
 - c. Children under the age of 8 – 1 adult per 3 children

Adult supervisors are required to follow all instruction and guidance provided by lifeguards and/or Inverness Pool Committee members or Inverness Board members.

- 11) There is a charge of the pool party for each group of guests that are not registered Inverness pool members as follows:
 - a. \$40 up to 10 guests
 - b. \$60 up to 20 guests
 - c. \$90 up to 35 guests
 - d. \$100 up to 45 guests
- 12) Parties with over 20 GUEST children (under 15 years old) must request ***at least a week in advance*** an additional lifeguard at the cost of \$20 per hour to be paid by the host/hostess.
- 13) If the party is cancelled within 24 hours prior to the party the host will forfeit the cost of the party.
- 14) The host/hostess may reschedule the party if it is done at least 48 hours prior to the party.
- 15) The general pool rules and regulations shall govern.
- 16) Alcohol is not permitted at the pool. However, the Board may consider whether to allow alcohol for an Inverness HOA community event on a case-by-case basis.**
- 17) No glass containers are allowed!
- 18) The member identified on the party request form must always be present during the event.**
- 19) No parties will be scheduled on Pool Committee community events.
- 20) All payments must be made in advance using the membership system. All charges are due before or on the day of the party.

Pool Party reservation processes

3. An invoice payment will be sent to you
4. Please pay it ASAP to guarantee your party slot
