UNSUPERVISED LAP SWIMMING

RELEASE FROM LIABILITY

To be signed by all unsupervised lap swim participants. Participants must be 18 years of age or older. No one under the age of 18 is permitted on JVRA property outside of pool operating hours. This release is valid for the 2026 swim season only.

In consideration of JVRA permitting participation in unsupervised lap swimming outside of pool operating hours, I, in full recognition and appreciation of any and all risks, hazards, or dangers inherent in this activity to which participant may be exposed do hereby acknowledge that I fully understand the risks involved and that I agree to assume all of the risks and responsibilities surrounding participation in this activity. I acknowledge that there are specific risks associated with swimming. I understand that I have the opportunity to ask questions to my satisfaction regarding any and all activities and associated risks prior to signing this document.

I understand that JVRA, its directors, officers, agents, servants, and employees assume and accept no liability for personal injury or loss of life or damage to personal property.

Further, I do for myself, my heirs, and personal representatives, hereby defend, hold harmless and indemnify, release, and forever discharge JVRA, its directors, officers, agents, servants, and employees from and against any and all claims, demands, and actions or causes of action on account of or resulting from participation in the aforesaid activity.

I understand that participation in the above activity is voluntary. I understand that participant **IS NOT** covered by any JVRA liability insurance.

I understand that during unsupervised lap swimming **no lifeguard will be on duty**. I understand that lap swimming is not permitted during pool maintenance shifts or swim team practices.

I agree to abide by all posted rules at all times including the following:

- Participants may not enter if impaired by alcohol, drugs, medication, illness, or a medical condition affecting safe swimming.
- Diving is prohibited except where expressly authorized.
- Participants must inspect conditions before entering and leave immediately if there is lightning, severe weather, unsafe water conditions, equipment problems, or suspected chemical imbalance.
- Participants must keep gates locked and may not admit anyone else onto the property.
- Emergencies, injuries, damage, water-quality concerns, or unauthorized entry must be reported promptly.
- The participant has provided an emergency contact and current phone number.

I agree to secure the pool upon departure.

I agree not to share access codes with any other persons (members or non-members). I understand that unauthorized disclosure of access codes may result in revocation of unsupervised lap swimming privileges.

I understand that only JVRA members over the age of 18 are permitted to participate in unsupervised lap swimming activities. I understand that guests, as well as members under the age of 18, are **NOT** permitted on JVRA property outside of pool operating hours.
